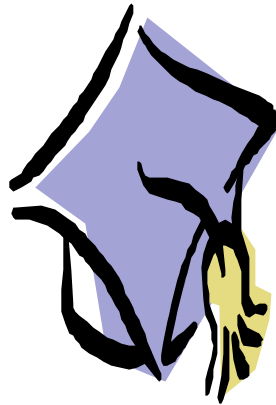

BC SCHOOL SPORTS 37th ANNUAL GENERAL MEETING MINUTES
Saturday May 14, 2005 at Kwantlen Park Secondary, Surrey.

1. **CALL TO ORDER:** (*Brian Lynch, BC SCHOOL SPORTS President, West Vancouver Secondary School*)
1.1 Welcome and Board Introductions: The President welcomed all delegates and observers to the 37th Annual General Meeting. The President introduced Mr. Barrie Lynch, parliamentarian who will be chairing the resolution portion of the meeting; he also introduced Karen Allison, recorder for the meeting.

Barrie Lynch gave background on being a professional parliamentarian and advised he will be using the newest edition of Roberts Rules (10th edition). Every person will have the opportunity to speak (up to 10min). There will be an additional opportunity to speak a second time but only after everyone has spoken once. He will be using a consent motion – if everybody is in agreement, the motion will be passed by consent. All comments will be directed through the parliamentarian, and he will ensure that comments will be made to the issue rather than to individuals. As parliamentarian, he is striving to achieve representation from the majority of the organization in attendance today. Barrie Lynch spoke to the specific bylaws as to what percentage is required to pass a motion or make amendments.

There has been an omission with respect to three constitutional items; namely the school membership fees for 2006 – 2007 as well as the election of officers for the new board of directors, and presentations of both candidates nominated for the position of Vice President.

There is also a request to allow that people from Vancouver Island be allowed to register late for votes. Under Roberts Rules, rules can be suspended that relate to parliamentary procedure.

Mr. Lynch asked that the membership consider suspending the constitutional rules as noted above to allow these exceptions for today's AGM. This will require a motion, vote and a 2/3 rule (or 75%):

MOTION: That the constitutional rules pertaining to the above items be suspended as they relate to parliamentary procedure to allow for Vice Presidential candidate speeches, late voter registrations and faxed updates of omitted resolution changes.

1.2 Introductions: All delegates and observers were asked to introduce themselves. The list of registered voting delegates and registered observers/guests is found in Appendix A and B. Each member of the Board of Directors introduced themselves.

Introduction of guests: Scott Braley, Sport and Recreation Director for LegaciesNow.

1.3 Declaration of Voting Rights, Rules of Order and Appointment of Parliamentarian and Scrutineers
(*Phil Cizmic, Vice President*)

1.3.1 Voting Rights: Each qualifying school that is a member in good standing at March 31, 2005 can exercise a vote at the BCSS Annual General Meeting, through duly registered proxies or by voting in person. (Article 6 – Bylaw 6.5) Quorum will include representation from at least 20% of the member schools present.

1.3.2 Rules of Order: In accordance with Bylaw XXII, the meeting will use the latest edition of Roberts Rules of order for any procedural issue for which provision or partial provision has not been made in the Bylaws.

1.3.3 Appointment of Parliamentarian: Barrie Lynch has been hired as this year's Parliamentarian.

1.3.4 Appointment of Scrutineers: Several individuals volunteered to keep track of the voting numbers throughout the Resolutions discussion. They were: Greg Smyth, Vic Bifano and Sean Lamoureux.

1.4 Nomination Procedures for the Board of Directors:

(Phil Cizmic, Vice-President) In accordance with Bylaw 7.2, all properly executed nominations forms had to be received at the BCSS office by March 25, 2005. Nominations will not be accepted from the floor. Elected Director terms expiring this AGM include:

- ? President
- ? Vice-President
- ? Zone C (North Central)
- ? Zone E (Vancouver Island)
- ? Zone F (Lower Mainland)
- ? Zone G (Fraser Valley)

There were nominations for each position with two nominations received for the position of Vice President. They were Rob Hallam from Rick Hansen and Phil Cizmic from Southgate Middle School. Elections will occur later in the meeting.

In addition to the above, two Sport Commissioner rep terms expire, and new appointments will be made for two of four appointed positions at the June Board of Directors meeting. (Boys Basketball and Badminton)

1.5 Outline of Resolution Procedures: *(Brian Lynch, President)* Delayed Resolutions, 17 a), b), and c) by the BCSS Board of Directors as presented and accepted at the 2004 AGM by the membership in attendance will be addressed first. Special Resolutions (dealing with Constitution or Bylaw changes) were due at the BCSS office by March 25, 2005 (Bylaw 18.2.2). Other resolutions were due on March 31, 2005. Resolutions to change the Constitution & Bylaws, Membership Fees, Operating or Competitive Policies will not be accepted from the floor.

1.6 Announcement of Registered Votes: The full BCSS Membership is 390 schools as of March 31, 2005. A quorum (20%) is 78 votes. 183 votes are present, in person or by proxy. 50% is 92 votes. A simple majority of votes is 93; 66.7% votes is 123; and 75% of votes is 138.

There are 97 votes represented in person with 86 votes represented by proxy.

2.0 ADOPTION OF AGENDA:

There were no additions to the agenda.

3.0 (A.) ADOPTION OF THE MINUTES OF THE 36th ANNUAL GENERAL MEETING HELD MAY 15, 2004:

That there be an amendment to the minutes from last year to reflect the presence of a motion to table the resolutions 17 a, b, and c and the ensuing discussion and that this motion was moved, seconded, and defeated.

It was noted that there was an omission from the minutes of 2004 and that a motion to table resolution 17B was not reflected in the minutes nor was a membership vote.

The Executive Director advised that in order for a motion to be recorded in the minutes, it must be an official motion, followed by a formal vote. She believed that there was only discussion around this particular resolution and therefore no information was recorded. Keenan also stated that if she made an error, the minutes should be amended to reflect this.

The parliamentarian provided an explanation of procedures regarding the recording of minutes.

3.0 (B) ELECTION OF VICE PRESIDENT:

Introduction, speeches and voting of Vice Presidential candidates:

Rob Hallan from Rick Hansen

Phil Cizmic from Southgate Middle School.

Voting commenced and was closed.

4.0 PRESENTATIONS TO, AND DISCUSSION WITH THE AGM DELEGATES:

4.1 Presentation of the Revised BCSS Strategic Plan

Brian Lynch reviewed the history and process of Strategic Plan development and reminded membership that it is a working document.

Power Point presentation provided an overview of the Mission, Vision, Values, SWOT analysis, (guiding principles), planning priorities and goals.

Vision: Every student in BC Schools will be a participant in school sports

Mission: Membership-based organization of schools which is in harmony with the aims of education as set forth by the Ministry of Education.

Priority areas: Financial planning, rules and regulations, communication, Human resources,

Discussion:

A member wondered if the intent of the presented mission statement reflects a change in the mission of the organization. Confirmed.

Sees that there is only one point that differs from the existing mission statement which is the point relating to being in harmony with the Ministry of Education. Concern that this means the Ministry of Education will chart the direction of BCSS; those who don't coach, who aren't involved in our schools and it will become a political process. Indication is that if we fail to reach harmony with the Ministry and LegaciesNow plan for 2010 then our funding will be cut. Concludes that previous mission statement represents the schools and members well and should not be altered.

A member respects the concerns but doesn't see the presented mission as one with much change and that it is representative of the organization. He supports the mission that the Board has worked hard to achieve.

The parliamentarian reiterated BCSS's preamble to the constitution.

A question was asked with respect to how people can give the board input into what has been presented today? Process?

It was suggested that input could be provided at the Commissioners' and Athletic Association Presidents' council meetings in the fall. The membership was also advised that there will be a board meeting in June and a management committee meeting in early September to which input can be directed to any member of the Board of Directors.

There was confirmation that the entire strategic plan is on the website and that it will come back to the membership for approval at the next AGM.

A member expressed a concern that not knowing the organization's mission for next year (until AGM 2006) will not help members with direction of BCSS. Dislikes the idea of nebulous mission statement for another year.

It was stated that everything that we have in place right now remains in place until there is a ratified change. This organization still functions under the existing mission.

Could the board provide membership with a timeline so that members can provide feedback that is impactful?

There is reference to ALL schools in the presentation. Clarification that this does not mean K-12.

This was confirmed.

5.0 REPORTS TO THE ANNUAL GENERAL MEETING:

5.1 President Report: (Brian Lynch)

Dominant issue – sports academies or schools, more specifically the resolutions pertaining to them.

Chronology of what has happened:

- Two weeks after 2004 AGM, a meeting was requested from Superintendents, School Trustees and some principals
- Meeting occurred in June – 7 people present, concerns expressed regarding 17 a,b, and c and the way they were passed.

Concerns were as follows:

- that they were in direct conflict with Ministry of Education
 - that it was in direct conflict with BCSS constitution
 - that there was an absence of definition for sport school/academy
 - over litigation and associated costs
 - Over enrollment and staffing for coming year
 - Regarding further alienation from Ministry of Education and therefore loss of provincial funding
- Board met by conference call in June and approved the following motion:
 - To delay implementation of 17 a,b,c for one year to define a sport school/Academy and gather more information on their impact.
 - Sought legal counsel to ensure that we could invoke 7.1.1 and 7.1.2
 - Board believes that this was the right thing to do. It was a unanimous decision.
 - Created an advisory group and tasked them with exploring the future impacts of this concept on a competitive balance for interschool sport competition.
 - Meetings were held in August, October and November. Recommendations to the Board in January.
 - Thanked the Advisory Group for their work.
 - Believe that solution is a workable situation.
 - Allowed us to reconnect with all stakeholders
 - Identified that we need to do a full review regarding policies and procedures for rules and regulations

Coaches Code of Conduct Hearing:

- There is one hearing active since last June that is now in the BC Supreme Court. Anticipating a decision, hopefully before the end of the school year.

Applauded all Sports Commissions on Hosting very successful provincial Championships again this year.

MOVED: {Bingham (George Elliot)} To accept the report and presentation.

5.2 Presentation of 2004-2005 Audited Financial Statements: (Sue Keenan)

The 2004-2005 Audited Financial Statement was pre-circulated to the membership. Sue Keenan provided a summary of the year by addressing the following four categories, General Operating, Gaming, Legal and LegaciesNow contingency funds.

Schedule 1 – dairy Foundation Milk Run update and changes reflected in the budget

Schedule 2 - \$9896 under professional development is in fact \$4000 for audit; the balance is for general legal opinions that are not specific to a case.

Schedule 3 - 2004 gaming audit showed too large a surplus so we are working with sport commissions to reduce the amount in fund as future gaming funding will be reduced or eliminated if we don't reduce the surplus.

Schedule 4 - \$30 000 in legal fees up to March 31; anticipating another \$15000 – 20000 before case is done.
2010 LegaciesNow: have spent funds to launch pilot projects

As a direct result, in partnership with PacificSport, we will be able to run a Sport Fun project that will see activities on Pro D days and any other school closure days. BCSS emphasis is on middle schools, PacificSport emphasis is on elementary schools. \$170000 over three years to be funneled through PacificSport accounts to implement this program.

Working to pay down deficit.

Comments: There has been a trend over the last four years where expenses are going up and revenues going down. Board had tough decisions to make to keep organization going in the right direction. He commends the board for trying to keep expenses down and that this is evident. What were the projects on Schedule 2 that decreased the operating expenses by \$13,000?

Small projects are:

- NCCP
- Milk Run project
- FairPlay poster
- BCOYLA

How are we going to generate more revenue?

Working with one major sponsor. Will be announced only when finalized.

Structure makes it hard to market itself for sponsor money. Is there a plan to get this together so everybody is working in a similar direction?

The Sport Commissions have expressed a willingness to work towards something in better cooperation.

PacificSport – only member schools are eligible.

Concern over manpower for project (BCSS Staffing)

BCSS contributes one member to advisory committee. PacificSport will carry burden of operations and program development/implementation.

MOVED { Moslin (Woodlands) } THAT THE 2004-2005 AUDITED FINANCIAL STATEMENT BE ACCEPTED AS CIRCULATED.

5.3 BOARD APPOINTEE REPORTS:

5.3.1 BC Superintendent's Association Appointee Report: (Bob Peacock, SD #58)

- Recognized coaches – provided thanks.
- Choice agenda – not just an agenda of school (and sports); it is part of life. Suggested that we see it as an opportunity.

- Parent Demands – no longer do parents sit back and accept what is being done. Must keep this at the forefront of what we do.
- BCSS in last year – has been on the table with the Superintendents more this year than ever before. Will work to keep it there.

5.3.2 BC School Trustee's Association Appointee Report: *(Andree Janyk, SD #48)*

- Recognized and thanked coaches and volunteer coaches.
- Choice – dealing with it more and more. Understand what choice means and as trustees we try to provide opportunities to meet the needs of students/parents.
- Concerns over 17a,b,c:
 - Passed without definition of what a sport school is.
 - Passed without definition of what an elite athlete is
 - 17b assumed some transferability from one sport to another, yet research doesn't support that
 - Included grades 8 and 9. Truly feel this is a developmental time of student's life. The more choice a student has at this age, the more potential they have to excel and be well rounded.
 - 2010 allows some opportunity that otherwise wouldn't exist.
 - Want to see the opportunity for choice
 - Would like to see support for resolutions 17a,b,c
 - Supportive of process

5.3.3 BC Principal's and Vice Principals' Association Appointee Report: *(Vic Bifano, SD #73).*

- Echoed comments of thanks.
- Will ensure that principals become and stay more involved in school sport.
- Good programs don't just happen; we all need to work together.
- BCSS is a part of a bigger system and we continue to have a vital role in the outcome of sport for youth.

5.3.4 BC Confederation of Parent Advisory Councils: *(Arnie Kidner)*

Not able to be here (PAC AGM today)

5.4 Executive Director's Report: *(Sue Keenan)*

In addition to the final report submitted, Sue discussed:

The EX-Net program – 90% of schools have adapted quite well. Most comments have been positive.

- Please contact when you first have a problem
- Print out your team rosters
- System built on integrity – only as good as data entry
- Some people have found loopholes. Please don't use them if you find them

Office Staff - Recognition of office staff

Thanks to Board and the difficult decisions they have had to make and those they will be faced with making around the resolutions of 17 a,b,and c. The Board has had to make tough leadership decisions for the future benefit of the organization and they have undertaken the necessary steps to ensure these were well-informed decisions.

Question: Fraser institute and Ministry of Education Ranking assume that data came from EX-Net, and wonders why it is so skewed when data comes from BCSS?

Response: EX-Net data was provided to them with qualifiers, but she doesn't know how data was manipulated. We must provide data but cannot provide student names (as prohibited by freedom of information and privacy act).

A request for clarification regarding the entry of names for every student in school, EX-Net attributes them to a team, regardless of whether or not they are on a team roster.

Confirmed that they will be registered as a school team member but not necessarily on a team roster.

A concern that reports in media are really felt by the schools and that it may result in schools trying to manipulate the data.
Suggestion that Sue speak with Ministry of Education and Fraser institute to explain impact of numbers when they are not accurately identified.
Sue suggested that she already provides that information to both parties but that maybe the best answer is to not provide any data. This would also account for issues in sports that are not properly represented (rowing, table tennis).

5.5 Council Report:

5.5.1 Council of Association Presidents: (*Sue Thorne, East Kootenays SSAA, Prince Charles Secondary*). There were no additions to the pre-circulated report.

5.5.2 Council of Sport Commissioners: (*Bill McNulty, Magee Secondary*)

Insurance has been a key issue: As host of provincial championships, people are not covered. Identification that this must change but we are still looking for solutions. Hoping for clarification at next meeting.
All Championships are going well – lots of growth in sport. There is a lack of growth in people coming in (volunteers) for sport support.
Costs going up, revenues are being sustained.

5.6 Standing Committee Reports:

5.6.1 Administrators' Committee: (*Greg Smyth, Alberni District*).

- Apologies for no written report.
- Thanks for work that is being done.
- Appreciation for sport for the students – coaches, volunteers, bus drivers; everybody who helps give students opportunity.
- Biggest message has been that the Administrators' Committee needs to wake up. It is time for the administrators to start taking an active role in sport

5.6.2 Competitive Standards Committee: (*Rod Morrison*) there were no additions to the pre-circulated report.

5.6.3 Coaching Development Committee: (*Don Moslin, Woodlands Secondary*) there were no additions to the pre-circulated report.

5.6.4 Eligibility Appeals Committee: (*Sue Thorne, Prince Charles*)
132 appeals, 52 granted eligibility, 62 Denied, 8 outstanding and 3 withdrawn

5.6.5 Jury of Appeal (*Jeanine Stannard, St. Margaret's School*)

Provided the following update to the pre-circulated report:
Is grateful that we do not see 500 appeals anymore. Voiced appreciation for the people who sit on the Jury.

5.6.6 Registration Appeals Committee: (*Phil Cizmlic, Southgate Middle School*) there was no written report, as the committee did not meet this year.

5.6.7 Scholarships & Academics Committee: (*Leslie Buchanan, West Vancouver Secondary*) there were no additions to the pre-circulated report.

MOVED: {Bingham (George Elliot)} THAT THE REPORTS 5.3, 5.4, 5.5, 5.6 BE ACCEPTED AS PRESENTED.

6.0 2004-2005 BC SCHOOL SPORTS AWARDS:

6.1 Outstanding School Awards:

Today BCSS recognizes those schools whose commitment to improving their school through athletics is outstanding. This year's award is shared between two schools, St. Anne's Academy and GlenEagle Secondary.

Randy Semenoff accepted on behalf of St. Anne's Academy.

Penny Andersen accepted on behalf of GlenEagle.

Honourable Mention: BCSS recognizes the growth for middle schools whose contributions are often overlooked. Special recognition was given this year to Eugene Reimer Middle School in Abbotsford.

Ryan Colbert accepted on behalf of Eugene Reimer Middle School.

At this time, Ryan Colbert introduced Mr. Eugene Reimer who attended in support of the recognition the school was receiving today.

Eugene Reimer: Paralympian, Canadian outstanding male athlete of the year, Order of Canada, BCSS Hall of Fame, Terry Fox Hall of Fame, BC Sports Hall of Fame.

Excellent model for all students, particularly those who attend the school that bears his name.

Resounding positive appreciation for contribution. Standing ovation from attending members for Mr. Reimer.

6.2 Honour Award:

Mr. Walt Kirschner from South Kamloops Secondary School was introduced to present the 2005 Honour Award.

He identified Brian Olthuis from South Kamloops Secondary as this year's recipient. Brian is a phys-ed teacher and coach at South Kamloops Secondary who started his career at Valleyview secondary. He has led teams to provincial championships in football in 1985,86 and 90, and has won the BC Lions Orange Helmet award. He also always attributes the dedication, commitment and sportsmanship of his athletes as the reason for success. Several athletes he has coached have gone on to play university and Canadian League football.

Brian Olthuis thanked Walt and the organization for the award.

7.0 RESOLUTIONS

7.1 Resolutions 17 a), b) and c)

1. **WHEREAS, the Board of Directors of BC SCHOOL SPORTS believes that 17 a), b), and c) as presented and accepted at the Annual General meeting in 2004 and outlined below:**

A) Any student/athlete participating in a "sports school" program is ineligible to participate in BCSS competition in the sport in which they are receiving the specialized training.

B) Any student/athlete transferring into a "sports school" program is ineligible to participate in any BCSS competition for twelve months from the date the transfer is physically completed.

C) Any student transferring from a "sports school" back to their "home school" is ineligible to compete in the specialized sport for six months from the date the transfer is physically completed, but is immediately eligible for all other BCSS competition for which they meet the eligibility requirements.

are unnecessarily punitive and restrictive.

MOVED (BIFANO, South Kamloops / SEMENOFF, St. Ann's) THAT RESOLUTIONS 17 A), B) and C) BE RESCINDED AS ORIGINALLY PRESENTED AND APPROVED BY THE MEMBERSHIP IN 2004.

BIFANO – It is clear that there would be problems with motions as presented and accepted by the membership in 2004: concern over lack of definitions and also the impact with the Ministry of Education's directive and its effect on students. These resolutions must be rescinded to enable changes that advisory group have to bring forward that will help clarify.

**Moved, seconded and passed to allow non-member to speak.
CARRIED**

MOTION

17c is the resolution in question. "next BCSS season of play". Urge not to rescind as effect in the US has not been positive.

Thinks that definitions need to be formed for 17b, and need to rescind.

**Moved, seconded and passed to allow non member to speak.
CARRIED**

MOTION

Requested clarification that if this motion is passed, then the membership goes onto proposed amendments. If motion is defeated, then the amendments are not available for discussion. Why can't the membership discuss the ability for amendments without rescinding the motion?

The parliamentarian replied the motion before the assembly is to rescind. The Scope of Notice is to rescind the motions and not amend them. Motions to amend something previously adopted would have needed to have been submitted in accordance with the provisions of the bylaws in order to entertain an amendment to 17 a,b and c.

A member indicated that he has worked with the group that has addressed sport schools including all representatives from sport and education. There has been huge research regarding sport academies/schools/etc. worldwide.

Gave examples of letters from students involved in sport schools. Both students have experienced success in both athletics and academics, and have stated that they would search for another school that would allow them to continue their pursuit of their chosen sport but maintain involvement in school sports.

Sport and education are now partnering to make policy that works for system.

Urged BCSS to rescind motion.

A member indicated that last year the resolutions were passed individually, and now we are being asked to vote on them as a package. Why can we not address these as individual motions?

MOTION {Guest (McMath)} that we deal with 17 a, b, and c separately rather than rescinding the motion as a whole package.

Discussion –Bifano – the advisory group dealt with this quite thoroughly, and felt that they received appropriate input from members.

17b is the issue and the motions 2,3,4,5 deal with 17b. Could we still use these motions if we do not rescind the motion?

The parliamentarian replied that No, motions 2,3,4,5 were only available for discussion dependent on the outcome of the vote for resolution 1. He further stated that the motions 2,3,4 & 5 were submitted as motions to be entertained dependent on resolution 1 being carried.

MOTION DEFEATED

Barrie Lynch indicated that the original Motion is to rescind the 17a,b, &c:

Discussion

Work hard to maintain a level playing field for the kids. Seconded the motion for resolutions last year but believes that this motion takes the politics out of it and is the best for the students.

Believes there were misconceptions last year about what these programs are trying to accomplish: These programs are NOT for elite athletes. They are programs to develop skills in sport and life. Misconception that these programs are huge magnets: this is not the case and there are very few non-catchment students. Transferability of skills – there is contradictory research on the transferability of skills

Believes that resolutions are restrictive and punitive; wonders why we as athletics focused adults, are being so restrictive.

Resolution is inconsistent with Ministry of Education policy of choice.

He believes that if we do not rescind and approve something similar as a compromise, we will jeopardize funding, relationship with Ministry of Education and overall benefit of programs of BCSS.

Coaches like to win. Serious injury occurred in a game against a school that has specialized training. Problems arise with specialized training, particularly in physical contact sport.

Wonders if these motions were put on hold so that definitions could be established. Supports rescinding so that it can address the concerns that have been raised.

Clarification – we suspended the rules this morning; why can't they occur this afternoon?

The parliamentarian stated that only rules in the bylaws that can be suspended are the parliamentary procedures relating to rules of order.

If motion is defeated, then we would have to wait until next year's AGM to address the additional resolutions?

Parliamentarian -that is correct.

From a small school, sees the opportunity for students when there isn't a program available. Looking at instituting a hockey school and they are in no way looking to recruit athletes from other schools. Passing the motion is more of a trust issue amongst membership rather than an issue of students.

We are losing sight of what we are here for. What is the opportunity cost of providing these kids with these opportunities? Develop the opportunity for a few kids? Must look at big picture and effect of choosing such a change.

Why was the decision to rescind the resolution rather than amend them?

BIFANO – the reason for rescinding is that the motions clearly don't reflect where we are now and the work that was done by the advisory group. He believes that the proposed motions will rectify any concerns.

Recognizes the work and honours the work done by the advisory group

We are dependent on volunteer coaching. Must protect the integrity and balance of the system.

Issue was brought on by parents, teachers, trustees. Board took this seriously. Warns that there are so many loopholes as the resolution stands. Support motion to rescind.

Disappointment in Board. How many times has this happened before? How was advisory group formed?

LYNCH - the board has never to the best of his knowledge taken the action to rescind a decision.

Further clarified how Advisory Group was formed:

asked for representation from key stakeholders, asked CARL REPP (Student athlete achievement project) to sit on board, two members of eligibility appeals committee, two members at large and President.

Concerned by continued focus on what appears to be punitive rules. Encouraged members to look at what is affecting all athletes, including the elite ones, and how we can positively impact all the student athletes.

Echoed concern regarding Board's decision to table the resolution last year – poor leadership and a lack of democratic process.

- o Sport academy programs developed for hockey and soccer, rather than BCSS primary sports.
- o The more sport schools that are allowed in an unregulated system, the more likely coaches will not want to volunteer their time
- o What's the difference between a sport school and a "regular" academic program

The parliamentarian sensing that the membership would like to move to closure as there has been an hour of discussion, suggests closing the discussion once the remaining speakers have had an opportunity to speak, then move on to vote.

Last year, this was late in the day, discussion was rushed and insufficient. Believes the Board has handled things the right way.

George Elliot is now a Sport School. Brought in Hockey program as they were losing some kids. None of them played any other school sport.

Choice and transfer are big topics; policies are based on the idea of the neighborhood school. The school is the only school so the resolution as stands is prohibitive.

Vote on Motion to rescind:

Challenge to come up with credits – what is an educational credit? Sees potential for huge number of appeals.

THORNE – This parallels the language in terms of a definition. 4 credits was an arbitrary number and is a starting point.

Question: Have started a district gold academy. Students stay at their own schools, but come together twice a week. These students are not transferring, but are enrolled in a sport specific education program.

THORNE – depends on how many credits they are receiving

BIFANO – if they are doing it on their own time (ie. Going to golf and country club), it should have no effect.

Question: Intent of motion is to define a sport specific education program? Could we have an amendment without 1 and 2?

The Parliamentarian stated, No, you have effectively closed that amendment and the membership would have to move to reopen the amendment

MOTION to reconsider the amendment prior to voting on 3a.

MOTION cannot be entertained.

BACK TO MAIN MOTION, 3a in its ENTIRETY:

Seems to only impact athletes if they transfer. Clarification?

BIFANO- doesn't impact them. This motion does not address these students.

Most PE classes are 4 credits. Therefore athletes can continue to take PE without being registered in a Sport Specific Education Program.

Middle school athletes: in grade 9 there will be men and boys, women and girls so they will be all over the place physiologically and will not present a level playing field.

A student in grade 10 is in their home school
A student entering grade 9, has not yet determined their home school.

By lumping these two motions together, we are creating a problem as to entering or in the 2nd year. If we accept the language, there are inconsistencies with transfer rules.
Entering is critical to the interpretation.

MOVED: {BRADLEY, (Mt Boucherie)} that the membership include the amendment to the proposed amendment which would include the word “entering” the 2nd year.

Urged the membership to include the second year in sport specific programs.

MOTION by BRADLEY was retracted.

Was thinking specifically about kids entering their third year. Sticking to grades 10, 11, 12.

Rules refer to DURING the school year. Entering implies something different as they are not “in”.

Encouraging for balance within school team and the potential for participation everybody, not just elite athletes. Understanding the impact of choices and that sometimes there are downfalls to that. Leaders and role models, athletes become these as a byproduct of competition.

Against the motion. Every time an athlete transfers, it does open up a spot for somebody on another team. Difficult to run an organization based on policies for exception. Recommend that BCSS look at tiering system.

Comment on perhaps the penalties should be on athletic directors and coaches.

This resolution might affect one position, however, it does potentially open it to more than half of the board being employed outside the system; being coaches or athletic directors.

This is an opportunity to make sure there is history in the organization, and that there are people committed to organization to be involved.

He is out of school for a year and doesn't feel he would be a good representative on board.

Many retired teachers still have desire to contribute their knowledge

Not just pertaining to Board, this motion also relates to standing committees.

Concerned that people are speaking on behalf of organization who are no longer connected to it. Believes that the Board in particular must be directly tied to the organization.

Critical for people to be aware of situations and organization. Lose touch very quickly once you are out.

8. **WHEREAS, a student's involvement in school sport provides opportunities and experiences that are important to the development of a well-rounded student, however, student-athletes must remember that their participation in school sport is a privilege, not a right.**

WHEREAS, a strong athletics program should compliment a school's academic program, participation in various school sports programs should be predicated upon successful work in the academic classroom. Academic eligibility is based upon the fundamental principle that each student must earn passing grades in the academic curriculum in order to be eligible to participate in athletics.

WHEREAS, academic eligibility rules enable member schools to maintain the appropriate balance between the academic and athletic programs offered at secondary schools.

WHEREAS, academic standards are proposed to ensure that in addition to athletic participation, a student should be on schedule to graduate with his/her class.

MOVED (THORNE, Prince Charles / MCNEILL, Seaquam) BE IT RESOLVED THAT TO BE ELIGIBLE FOR ATHLETICS DURING THE NEXT TERM, THE STUDENT MUST HAVE MAINTAINED A MINIMUM OF 2.0 GPA ON A 4.0 SCALE, OR ITS EQUIVALENT, AND FAILED NO MORE THAN ONE ACADEMIC COURSE.

- IT SHALL BE THE DUTY OF THE PRINCIPAL OR DESIGNATE TO HAVE EACH STUDENT'S ACADEMIC RECORD CHECKED AT THE END OF EACH TERM AND TO DECLARE THE STUDENT ELIGIBLE OR INELIGIBLE FOR THE FOLLOWING TERM BASED UPON THE CUMULATIVE GPA (GRADE POINT AVERAGE) ATTAINED BY THE STUDENT.

- ACADEMIC ELIGIBILITY OF ALL STUDENTS SHALL BE CONSIDERED AS OFFICIAL AND DETERMINING ONLY ON THE PUBLISHED DATE WHEN REPORT CARDS FOR THAT TERM ARE TO BE ISSUED TO THE PARENTS.
- A STUDENT WHO FAILED TO OBTAIN THE MINIMUM 2.0 GPA OR FAILED MORE THAN ONE COURSE SHALL BE INELIGIBLE FOR ATHLETICS FOR THE ENTIRE NEXT TERM.
- ALL INCOMING GRADE 8 STUDENTS ARE IMMEDIATELY ELIGIBLE FOR THE FIRST TERM.
- ALL WORK REQUIRED FOR CREDIT MUST BE COMPLETED BEFORE THE LAST DAY OF THE GRADING TERM, WITHOUT ANY EXTENSION OF TIME.
- SPECIAL EDUCATION STUDENTS SHALL NOT BE DENIED ELIGIBILITY ON THE BASIS OF SCHOLARSHIP IF THE STUDENT IS MAKING ADEQUATE PROGRESS, AS DETERMINED BY THE SCHOOL ADMINISTRATION, TOWARD THE GOALS AND OBJECTIVES ON THE STUDENT'S INDIVIDUALIZED EDUCATION PROGRAM.
- SCHOOLS MAY ADOPT MORE STRICT ACADEMIC ELIGIBILITY POLICY.
- A GRADE OF "INCOMPLETE" ORIGINALLY REPORTED BY A TEACHER AT THE END OF A TERM, IS CONSIDERED A FAILING GRADE. IF A STUDENT IS ILL OR OUT OF SCHOOL, BASED ON AN EXCUSED ABSENCE, ON CONCLUSION OF THE TERM, THE STUDENT MUST BE WITHHELD FROM COMPETITION UNTIL THE SCHOOL WORK HAS BEEN SUCCESSFULLY COMPLETED AND A GRADE ASSIGNED.
- **DEFINITION OF AN ACADEMIC COURSE:** AN ACADEMIC COURSE IS ONE FOR WHICH CREDIT TO MEET MINIMUM REQUIREMENTS FOR GRADUATION IS GRANTED.
- **DEFINITION OF A TERM:** THE PUBLISHED DATE WHEN REPORT CARDS FOR THAT TERM ARE TO BE ISSUED TO THE PARENTS.

Deals with things that can be made more efficient, things that need to be modified and things that make membership think. This is done throughout the USA and process has been embraced. This is motion that she received most calls about. This is the responsibility of the school and should not be the role of BCSS. All coaches would love to have their athletes reaching sufficient academic grades, however, enforcing it would be a nightmare. Incompletes are meant for "you're not there yet" whereas this effectively says they cannot play.

- 1) COPY OF PR CARD / OR SCHOOL REGISTRATION DOCUMENTS THAT INDICATES THEY HAVE PREVIOUSLY ATTENDED THAT MEMBER SCHOOL IN PRECEEDING YEARS AS WELL AS THE CURRENT YEAR
- 2) WRITTEN VERIFICATION THAT THE STUDENT HAS PARTICIPATED ON THAT PARTICULAR TEAM OR INDIVIDUAL SPORT FOR THAT SCHOOL DURING THAT SCHOOL YEAR. (team roster lists, score cards, team uniform deposit receipts etc.)

THEN THE SCHOOL WILL BE ASSESSED AN AUTOMATIC FINE OF \$250.00 WHICH MUST BE PAID PRIOR TO THE STUDENT'S NAME BEING ENTERED BY BCSS ON THE ON-LINE BCSS PLAYER REGISTRATION FORM.

Doesn't believe that student athlete be penalized for the error of the administration. It punishes the student unduly. This would be a good way to failsafe the system and ensure the competition can go through as intended.

THE APPEAL MUST INCLUDE A COPY OF THE SCHOOL'S COURSE DESCRIPTION HANDBOOK INFORMATION FOR THE APPLICABLE CPP (OR **EQUIVALENT PROGRAM**).
