Motion by David Prissinotti

FIELD HOCKEY AA BC BERTHING MOTION

For the 2017 season, the BCSSGFHA will run a 16 team AA BC Championship tournament, adopting the following berthing formula outlined below. At the conclusion of the 2017 season, this format will be assessed and discussed to determine whether future AA provincial tournaments should remain 16 teams or return to 12 teams.

Rationale:

- A 16 team AA BC Championship berthing formula is consistent with the
 mission and values of BCSS in promoting and encouraging the participation
 in sport, assisting schools in the building of programs, supports equity and
 opportunity for participation and importantly, promotes and ensure that
 quality hockey teams have an opportunity to compete at AA BC
 Championships.
- This motion is also consistent with the objectives of the BCSSGFHA as stated in the constitution and bylaws to foster, promote, and encourage the development and organization of secondary school field hockey within the province of British Columbia.
- Lack of clarity over berthing for the AA BC Provincial Championships over the past few years, we hope the BCSSGFHA considers a review and update to rules and regulations governing entry in the BCSSGFHA AA Provincial Tournament to clarify for all concerned in advance of the start of the season.

This motion address several issues:

a) AA field hockey is arguably the shortest team season of any BCSS sanctioned sport. Many teams start around Sept. 20 and last meaning games played by Oct 20. Seasons are also disrupted by outdoor ed. camps. We hope to create a longer season and more opportunity for more student athletes to be involved in meaningful games than under our current 12-team model. Adopting this motion will generate more meaningful games, for many more teams, much later in the season. Depending on format and interest for play in berths, 22-25 teams could still be active late in October vying for final berths.

- b) Teams and league currently do not know the number of berths each zone will get until mid-October, which creates challenges in scheduling. Adopting the motion would clarify the path for teams, leagues, and zones to know in advance how many berths (minimum) and the pathway to those berths for scheduling.
- c) AA field hockey has the smallest discrepancy between the numbers of registered teams in each zone of any BCSS sport, which results in extraordinary allocated berth discrepancies. For example in 2016: 4 teams = 1.5 berths, while 5 teams = 2 full berths, and 6 teams=2.5 berths. The difference in number of teams is minimal, whereas the resulting berth allocation is substantial. Each year, berths are highly contentious and exclude some top teams in BC, thus creating ill-feeling in the hockey community.
- d) Some of the strongest AA teams in BC have no avenue to qualify for the BC's under the current berthing formula for a 12 team tournament. Concern in *part c* compounds this issue. Based on season results, it is clear that teams who would place in the top 6 in BC over the past few years are excluded from the BC Championship. This past season, arguably teams ranked 4, 5, 7 in BC were playing off for 1 berth to the BC's.
- e) Regional discrepancies for travel, cost and field hockey resources create issues where a province-wide formats fail to address regional sensitivities. The proposed motion allows for regions to manage their known path (see *part b* above) to access the AA BC Provincial Championships.

For the 2017 season, the BCSSGFHA will run a 16 team AA BC Championship tournament, adopting the following berthing formula outlined below. 1. 11 Fixed Berths based on historical registration numbers:

- **a.** Koot. (3teams) 1 berth
- **b.** OK (4-5 teams) 2 berths
- **c.** FV (7-9 teams) 3 berths
- **d.** VR (4-5 teams) 1 berths
- **e.** VI (5-6 teams) 2 berths
- **f.** NS (3-4 teams) 1 berth
- g. + Host 1 berth

¹¹ berths are allocated based on past five years of historical registration numbers. These berths are fixed so that each zone knows that they are assured these berths prior to the start of the season.

2. "Play In" berths - 5 berths

a. 1 berth to OK & Kootany

• to be determined regionally, as is feasible considering location, travel costs, etc. (ie. OK3 vs Koot2 or mini tournament including Koot 2, Koot 3, OK3, OK4)

b. 3 berths to FV, VR, NS

- to be determined regionally, as is feasible (ie. a mini qualification tournament that could include 4-8 teams, such as: VR2, VR3, NS2, NS3, FV4, FV5)
- travel costs are greatly reduced and field access is less of an issue so a tournament is a feasible way to involve more teams late in the season playing meaningful games

c. 1 berth to VI

• to be determined regionally, as is feasible (ie. VI3 vs VI4, simply VI3, or access to a team in the North Island unable to compete at an Island tournament)

HOW DOES THIS LOOK?

There is great flexibility in how WC are allocated and the number of WC games played. In order to provide examples as to how this formula would work, below are several possibilities.

EXAMPLE A – this example has 20-26 teams playing meaningful games until late October. 11 set berths based on current format for berthing with as many as 15 more teams competing for the final 5 berths. It is possible that 26 teams total are still active playing meaningful games until the end of October with 16 continuing on to AA BC Championships during the first week of November.

Koot. (3teams) – 1 berth OK (4-5 teams) - 2 berths FV (7-9 teams) - 3 berths VR (4-5 teams) - 1 berths VI (5-6 teams) – 2 berths NS (3 teams) – 1 berth + Host-1 berth

"Play In" Berths - must be completed by Oct. 28 or date TBD

- 1 berth to OK-Koot. OK3 vs Koot2 in a challenge game in late October. Or, to be determined as they see fit.
- 3 berths to VR, NS, FV. Regional Reps talk to their teams and decide how many teams from their region wish to compete. The Regional Rep declares how many from their region intends to compete for play in berths. VR2 and VR3, NS2, NS3 and

FV4 and FV5 all commit to competing for these berths. A one day, 6 team mini tournament is played in late October to award these 3 berths. Or, if a tournament doesn't work, a series of knock-out games between regions, i.e: VR2 vs. NS3, FV4 vs VR3, FV5 vs. NS2.

• 1 berth to VI. An extra challenge game is played to determine island 3-4 or, to be determined as they see fit.

These 5 qualifying teams take the 12th spot from the current format and the newly allocated 13-14-15-16 into the AA Championship draw.

Fraser Valley Girls AA Field Hockey

Zone Rep Report: November 2015

League Structure:

In the Fraser Valley, we had a AA league that did not interlock with AAA teams. We had ten registered teams in our zone though one folded mid-season, and six that competed at the Fraser Valley Championship. Initially we thought we had a much smaller number of AA teams and as such had just four teams in our league, but at the start of October we found out that some had been incorrectly put in the AAA league and others were in a Coquitlam/Maple Ridge league so we made adjustments to the AA playoff format to give these teams a chance to compete for a provincial berth. Our playoffs were a one day tournament held at Southridge Secondary.

Other Info:

- * Junior programs are becoming scarce. We have less than ten teams in the Fraser Valley at the Junior level. The Juniors had a one day Fraser Valley tournament held in Chilliwack. GW Graham defeated Westview in the final.
- * Some schools are not fielding teams because they cannot find coaches. We know there are many club players and even regional players who live in our zone yet their schools are not fielding field hockey teams
- * Umpire availability is an issue. Coaches are still sometimes needing to umpire their own games.
- * We have a new commissioner this year in the Fraser Valley Michelle Savich (Sardis coach) has taken over from Barb Kroeker. Michelle is a AAA coach so I keep her updated with what goes on with our AA league.

Vancouver Island Zone Report: Submitted by David Kerr SMUS **Zone Report -Nov 2016**

From last year, much has not changed within the zone.

The Island is split into regions - the South Island, which is essentially Victoria, and the North Island, representing all schools north of the Malahat.

In Victoria, the number of schools at AA level was similar to last year with competition between SMUS, GNS and Lambrick, but a league consisting of interlocking matches against AAA teams, which provides good competition and more variety of opposition. There was also a development league which included teams from Oak Bay, SMUS, GNS and Reynolds, and provided friendly competition at a Tier 2 level.

In league play, SMUS came 1st, GNS 2nd and Lambrick 3rd. SMUS went on to win the "best in the city" against Mt. Doug, who were the best AAA team.

As in previous years, practices were generally on the rubber turfs at UVic or at GNS, while matches were evenly spread out between the UVic water turf and rubber turfs.

North of the Malahat, the AA teams included Brentwood College, Isfeld and ?.

The resulting Island championships at Duncan had 4 teams entered, but Lambrick dropped out last minute due to insufficient numbers. The placings were:

- 1 SMUS
- 2 Brentwood

3 - GNS

GNS lost their wild card games to LFA and Eventual winners Seycove.

For the first time, there was a Tier 2 Island Championship held in Nanaimo, featuring teams from AA and AAA schools from Victoria to Campbell River.

Overall, the state of the game at the top end on the Island is pretty static. The Cowichan area is strong for AAA schools, and Oak Bay and Mt Doug also made the AAA provincials, but there is a significant drop off after these schools. For the AA schools, SMUS, Brentwood and GNS are dominating, but the hope is more can be done in Lambrick and other AA schools who have played teams in the past, like St. Margaret's. The turfs are there, the umpires are there, and there is a pretty good Middle School participation rate, but without the skills, motivation and enthusiasm of teacher sponsors or coaches in the high schools, the number of high schools putting out teams is limited.
