39th ANNUAL GENERAL MEETING MINUTES
Saturday May 12, 2007 at Fraser Heights Secondary.

1. **CALL TO ORDER:** (Raj Puri, President, (Kwantlen Park Secondary School)
 - 1.1. **Welcome and Opening Remarks:** The President welcomed all delegates and observers to the 39th Annual General Meeting. He Thanked Andrew Holland and Fraser Heights for hosting.
 - 1.2. **Meeting Information and Announcements:** General information about the meeting and announcements for the day's proceedings were made.
 - 1.3. **Introductions:** The President introduced members of the BC SCHOOL SPORTS Board of Directors. Guests included: Murray Morrison, with regrets from Aaron Mitchell, Mark Cassell, Laurey-Ann Roodenburg. The list of registered voting delegates and registered observers is found in Appendix A and B.
 - 1.4. **Declaration of Voting Rights, Rules of Order and Appointment of Parliamentarian and Scrutineers:** (Randy Semenoff, Vice President)
 - 1.4.1. **Voting Rights:** Each qualifying school who is a member in good standing at March 31, 2007 can exercise a vote at the BCSS Annual General Meeting, through duly registered proxies or by voting in person. (Article 6 – Bylaw 6.5)
 - 1.4.2. **Rules of Order:** In accordance with Bylaw XXII, the meeting will use the latest edition of Robert's Rules of Order for any procedural issue for which provision or partial provision has not been made in the Bylaws.
 - 1.4.3. **Appointment of Scrutineers and Parliamentarian:** Several individuals volunteered to keep track of the voting numbers throughout the Resolutions discussion. They were: Raj Puri, Randy Semenoff, Jim Martin, Andrew Holland, and Phil Cizmic. Mr. **Barrie Lynch**, the Parliamentarian who will be chairing the resolution portion of the meeting, was introduced.
 - 1.5. **Nomination Procedures for the Board of Directors:** (Randy Semenoff, Vice-President) In accordance with Bylaw 7.2, all properly executed nomination forms had to be received at the BCSS office by March 23, 2007. (Nominations will not be accepted from the floor.) Elected Director positions available for nomination were:
 1. 2nd Vice-President
 2. 3 Athletic Association Presidents as elected by the Presidents and
 3. 1 Sport Commissioner – Mountain Biking as previously agreed to on a rotational basis.

In addition, the make-up of the Board of Directors and the changes approved by the membership in 2006 through special resolution will now be implemented.
 - 1.6. **Outline of Resolution Procedures:** (Raj Puri, President) Special Resolutions (dealing with Constitution or Bylaw changes) were due at the BCSS office by March 23, 2007(Bylaw 18.2.2). Other resolutions were due on March 30, 2007. (Resolutions to change the Constitution & Bylaws, Membership Fees, Operating or Competitive Policies will **NOT** be accepted from the floor.)
 - 1.7. **Announcement of Registered Votes:** The full BCSS Membership is 424 schools as of March 30, 2007. A quorum (20%) is **85** votes. 124 votes are present, in person or by proxy. A

simple majority of votes is; 51 % votes is 63; and 75% of votes is 93.

There are 39 votes represented in person, 85 votes are represented by proxy.

5. New format of the Competitive Rule and Regulations

WHEREAS many coaches, athletic directors, administrators and parents have expressed a feeling of confusion when reading the Competitive Rules and Regulations,

And

WHEREAS the Rules and Regulations Committee has sought feedback and considered all feedback from all members,

MOVED: {SEMENOFF, (Brocklehurst) / THORNE, (Prince Charles)} BE IT RESOLVED THAT THE "NEW" FORMAT FOR THE COMPETITIVE RULES AND REGULATIONS BE ADOPTED AS PRESENTED. (**SEE ATTACHED PACKAGE-DRAFT4 AND ADDITIONAL REALIGNMENT SUMMARY PAGE**).

At this point a very brief description of the format changes was given by Randy Semenov.

The presiding Officer Mr. Lynch proposed that, as item numbers 6, 8 & 14 of the following section all dealt with items on the realignment summary page, that they be included in the vote on this item.

WHEREAS the jurisdiction process needs to be more clearly defined,

WHEREAS 6.3.1.3 (E1.3) allows for a team to be penalized more than once for one error,

9. 6.3.5. (D4.) Movement Between Teams (page 102)

WHEREAS there is a need to provide more clarity as to the intent of this entire section, to eliminate the ongoing confusion and breach of these rules.

MOVED: {THORNE, (Prince Charles) / BRADY, (Clearwater)} BE IT RESOLVED THAT THE FOLLOWING WORDING REPLACE REGULATION 6.3.5.1 (E4.2) AS FOLLOWS:

***INDIVIDUAL STUDENTS PLAYING UP:** A STUDENT CAN PARTICIPATE IN UP TO FOUR (4) PLAYING DAYS OF EITHER RESTRICTED OR UNRESTRICTED COMPETITION AT A HIGHER AGE LEVEL THAN THE TEAM FOR WHICH THE STUDENT IS REGISTERED.

ONLY TWO (2) OF THE FOUR (4) PLAYING DAYS MAY INVOLVE RESTRICTED COMPETITION.

THE STUDENT CAN ONLY PLAY UP AT THE SENIOR SCHOOL INTO WHICH THE STUDENT'S SCHOOL DIRECTLY FEEDS.

ON THE FIFTH (5) PLAYING DAY OVER-ALL OR THE THIRD (3) PLAYING DAY INVOLVING RESTRICTED COMPETITION, THE PLAYER REMAINS WITH THE HIGHER AGE LEVEL TEAM AND MUST BE IMMEDIATELY REGISTERED WITH THE HIGHER AGE LEVEL TEAM.

***(NOTE: ANY DAYS THAT A TEAM PLAYS UP (6.3.5.0) MUST BE INCLUDED IN THE OVERALL CALCULATION OF THE TOTAL NUMBER OF DAYS ALLOWABLE FOR PLAYING UP BY EACH INDIVIDUAL STUDENT-ATHLETE.)**

10. 6.3.5.1. a) (D4.2.1) Limits to playing up for play-offs / post-season (page 103)

WHEREAS the wording of this rule is confusing,

MOVED: {SEMENOFF, (Brocklehurst) / THORNE, (Prince Charles)} BE IT RESOLVED THAT THE WORDING BE SIMPLIFIED TO THE FOLLOWING:

“A STUDENT-ATHLETE WHO PLAYS UP TO A MORE SENIOR LEVEL PLAY- OFF / POST-SEASON PLAY IS INELIGIBLE TO RETURN TO PLAY IN ANY COMPETITION IN ANY LOWER AGE GROUP (THIS INCLUDES GRADE 8 AND 9 COMPETITION) IN THAT SPORT IN ANY SEASON OF PLAY THAT SCHOOL YEAR.

There was a little discussion to clarify the meaning.

11. 6.3.16.3 (D12.3) Student Transfers to another School in BC (page 108)

WHEREAS the preamble to the BC SCHOOL SPORTS Constitution sites the principle of participation as a purpose,

And

WHEREAS 6.3.16.3 (a) currently limits some student-athletes' opportunity to participate,

And

WHEREAS there is a desire to clarify the restrictions on transfer after the start of the 3rd year of eligibility;

MOVED: {THORNE, (Prince Charles) / SEMENOFF, (Brocklehurst)} BE IT RESOLVED THAT THE WORDS 'CLUB, COMMUNITY, OR REPRESENTATIVE' BE DELETED AND THIS SECTION BE AMENDED TO READ;

6.3.16.3 Transfers During 3rd, 4th and 5th Year of Eligibility: A student who transfers from his/ her "home school" after the start of his/her 3rd year of eligibility (~~ie: during 3rd, 4th or 5th year~~) is ineligible for a period of twelve (12) months from the date of transfer to participate in any school sport(s) in which he/she was registered for a member school in the 12 months prior to the date of transfer unless one of the conditions 6.3.16.3 1 a - n is met. ~~will retain his/her athletic eligibility only if the conditions of any of 6.3.16.3 (a) – 6.3.16.3 (n) are met. If the student does not meet any one of the regulations in 6.3.16.3 , the student will sit out from BCSS-approved sports restricted competition for 12 months from the date of transfer.~~

At the time of on-line registration of a transferred student as an "eligible student" in the school, there must be a confirmation as to why the student is eligible. This will usually be done through the on-line registration system. Please read the conditions below carefully to determine if additional confirmation is required.

In addition to completion of the transfer form as part of the on-line registration process, a "Compliance and Authorization form" must submitted and be signed by the Principal and Athletic Directors of both the leaving and receiving schools, and by the student's parent or legal guardian, confirming that:

~~a) Student Transfers to Another School in BC. If a student transfers to a school in BC after the start of their 3rd year of eligibility or Grade 10 then that student will only be eligible to participate in restricted competition in any sport in which they have not participated for any school, club, community or representative team during the 12 months prior to the date of transfer. (May 2006)~~

~~i) the student is not eligible to participate in restricted competition in any sport in which he / she did participate in the 12-month period prior to the transfer.~~

b) a) Student Advancing to a More Senior School:

i) A student graduating from a middle school or junior secondary school may proceed to the school into which his/her middle school or junior secondary school normally feeds, without any restrictions.

ii) Notwithstanding a-i) above, a student graduating from a junior secondary may proceed to any other public school in the same school district, as long as District policy is followed, and the Principals and Athletic Directors of the two (2) schools involved are in agreement that the move is for academic program reasons. ("Confirmation of Eligible Student Transfer Form" must be completed on-line with the registration of the student on the on-line Player Registration Form)

iii) If the student attended an Independent School not offering senior grades, this student can transfer to a similar Independent School offering senior grades, providing the receiving school is the closest similar Independent School geographically to where the student lives.

The student can also advance to a public school offering senior grades, as per the normal catchment boundaries of the school district in which the student resides. ("Confirmation of Eligible Student Transfer Form" must be completed on-line with the registration of the student on the on-line Player Registration Form)

⇨ b) New School Constructed, School District Reorganized or School is Closed

School Districts and /or schools must apply for approval from the BC School Sports Compliance Officer prior to any student being eligible. A complete list of those students impacted must be provided to BCSS with the following information for each student:

a) name b) date of birth c) current grade d) grade 8 entry date

e) previous school f) new school g) will they be attending their catchment school? Yes or No

h) If No to g) then reasons for choosing the school needs to be identified.

i) A New School Opened the student transfers because either 1) a new public school is opened and the school district either assigns students to the school or provides an option to attend the new school, or

2) a new public school is opened, the neighbourhood boundaries are changed, and the district requires students to transfer to the school in their new district neighbourhood

ii) School District Reorganization the student transfers because a school district either reconfigures a school or combines schools and assigns students to the reconfigured or combined school for any reason, or provides the student with an option to attend the reconfigured or combined school for academic purposes.

iii) A School is Closed the student transfers because either

1) a public school is closed and the students from the closed school transfer to their catchment public school, or

2) an independent school is closed and the students from the closed school transfer either to the geographically closest independent school (to their residence) of the same type (i.e.: Catholic to Catholic, Christian to Christian), or to their catchment public school

⇨ c) Parental / Legal Guardian Change Of Principal Residence: the student and his / her parents or the student and his / her legal guardian (see 6.1.7 for BCSS definition of legal guardian) have changed their principal residence within the previous 12 months. The expectation of the BCSS membership is that this move is long-term and that the new living circumstances will be maintained. For the purpose of these athletic eligibility regulations, legal guardianship must be in place for at least 12 months prior to the change of principal residence. * A statutory declaration must be completed and signed by the parent (s) and submitted to the home school for confirmation prior to being forwarded to the BCSS office.

i) **Move within the Same Public School District:** If the new principal residence is within the boundaries of the same school district, the student can remain eligible by not changing schools, or will be immediately eligible at the public school into whose catchment boundaries the family has moved. ("Confirmation of Eligible Student Transfer Form" must be completed on-line with the registration of the student on the on-line Player Registration Form)

ii) **Move into a Different Public School District :** If the parents' or legal guardians' new principal residence is in a different public school district, the student will be eligible at any public school in the new district in accordance with school district policy concerning student placements, or will be eligible at any Independent School whose main school building is located within the geographical boundaries of the new public school district. ("Confirmation of Eligible Student Transfer Form" must be completed on-line with the registration of the student on the on-line Player Registration Form)

iii) **Move to within the Parish Boundary of the Applicable Regional Secondary Catholic School:** If the parents' or

legal guardians' new principal residence is within the boundary of a different parish than the one in which the family previously lived, and the student transfers from one Regional Secondary to the Regional Secondary school located within the boundary of the new parish, the student remains eligible. ("Confirmation of Eligible Student Transfer Form" must be completed on-line with the registration of the student on the on-line Player Registration Form)

e) d) Parent to Parent Move : the student transfers from one school to another school in order to reside with the parent with whom he/she has not been living. Only two transfers for the purpose of moving from parent to parent are allowed during the five year eligibility period. If the move is within the same school district, the eligible transfer must be to the school within whose catchment area the receiving parent lives, and must be a transfer into the same kind of school (i.e.: public to public, regional secondary to regional secondary, independent to independent). If the move is from within the boundaries of one school district into another, the student will be eligible at any public or independent school within the geographical boundaries of the new school district. (See 6.3.17.1.a) for appeal information) ("Confirmation of Eligible Student Transfer Form" must be completed on-line with the registration of the student on the on-line Player Registration Form) * A statutory declaration must be completed and signed by the parent (s) and submitted to the home school for confirmation prior to being forwarded to the BCSS office.

f) e) District Academic Program: A student in their 3rd or 4th year of eligibility in a public school transfers to another public school in the same school district for a special, short-term academic program that meets the conditions outlined below. The student is only eligible to compete for their original school. The district academic program must meet all of the following conditions for the student to be eligible to compete at their original school during attendance at the district academic program.

(i) the district academic program is no more than one school year in length

(ii) the student will be returning to their original school immediately upon the conclusion of the district academic program

(iii) the program is a district academic program housed at the particular receiving school

(iv) the district academic program is a coherent program, not just a series of courses

(v) the program is not a career preparation program. If the student wishes to participate in restricted competition for the school housing the special district academic program, the school must file an eligibility appeal in accordance with part 4 of these regulations. If the student does participate for the receiving school in either restricted or unrestricted competition, they will not be eligible at their original school upon return after the conclusion of the district academic program. {see 6.3.16.3 (h)} ("Confirmation of Eligible Student Transfer Form" must be completed on-line with the registration of the student on the on-line Player Registration Form).

g) f) Alternate Program / Schools: If an alternate program / school is an offshoot of a particular Member School (home school) , and is administered by that home school's principal, the students in the alternate program are eligible to compete for the home school. If a student transfers to an alternate program administered by a different principal, the move is considered to be a transfer, and transfer restrictions shall apply. ("Confirmation of Eligible Student Transfer Form" must be completed on-line with the registration of the student on the on-line Player Registration Form).

h) g) Student Transferring from an Alternate School or Distance Education School:

i) a student who is attending an alternate school in a school district remains eligible upon transfer to the public school in whose catchment area the student resides.

ii) a student who is registered at a Ministry of Education Distance Education School remains eligible upon transfer to the public school in whose catchment area the student resides. ("Confirmation of Eligible Student Transfer Form" must be completed on-line with the registration of the student on the on-line Player Registration Form)

i) h) Short Term Transfer and Return to Home School: A student who transfers to another school for a period of one school year or less, and who has not participated in interschool competition in any BCSS-

approved sport while attending that school, will regain athletic eligibility upon transferring back to his/her home school. ("Confirmation of Eligible Student Transfer Form" must be completed on-line with the registration of the student on the on-line Player Registration Form)

j) i) Incoming Exchange Student: A student who transfers into a BCSS Member School as an incoming exchange student is eligible to compete for the receiving school only if the conditions in either i) or ii) are met:

i) Non-profit Exchange Program

1) the student is registered as a student in a BCSS-approved exchange program and appropriate confirmation is submitted during on-line registration.

2) the student is only eligible for the duration of the actual exchange program.

3) the British Columbia family with whom the student is residing is considered to be the family of record for the duration of the student's stay.

4) the student's exchange period in BC is of at least 5 months or one semester's duration. The only exception will be for the BC Ministry of Education Germany and Quebec exchanges.

5) the student is eligible as per all other BCSS eligibility policies, including age and the eligibility calendar.

6) the student has not graduated from the high school program in their home country or province.

As of May 2003, BCSS approved Exchange Programs are AFS Inter-culture Canada, Cultural Home-stay International, Educational Foundation Exchange, Rotary International Exchange, Student Travel Schools, World Youth Services and the Ministry of Education German and Quebec Exchange Programs ("Confirmation of Eligible Student Transfer Form" must be completed on-line with the registration of the student on the on-line Player Registration Form)

ii) School-to-School Exchange Programs

1) the school-to-school exchange agreement has been in place at least 5 years prior to automatic eligibility status being conveyed, and the exchange program must go in both directions.

2) the appropriate registration confirmation is submitted during on-line registration.

3) the student is only eligible for the duration of the actual exchange program.

4) the British Columbia family with whom the student is residing is considered to be the family of record for the duration of the student's stay.

5) the student's exchange period in BC is of at least 5 months or one semester's duration.

6) the student is eligible as per all other BCSS eligibility policies, including age and the eligibility calendar.

7) the student has not graduated from the high school program in their home country or province. ("Confirmation of Eligible Student Transfer Form" must be completed on-line with the registration of the student on the on-line Player Registration Form)

k) j) Boarding School Students: A student transferring into a boarding school is immediately eligible to compete for the receiving school if the student meets the conditions of i) or ii):

i) the student is transferring from a British Columbia public or independent school to a BCSS Member School as a boarder, and

1) both the leaving school and the boarding school submit letters supporting the transfer, the request for athletic eligibility and confirming that the student has not transferred for athletic reasons, and

2) the incoming student will be enrolled at the boarding school for at least 5 consecutive months, or one

semester.

3) The student will only be eligible to participate in restricted competition in any sport in which they have not participated (practice or competition) for any school, club, community or representative team or level during the 12 months prior to the date of transfer. The student is not eligible to participate in restricted competition in any sport in which he / she did participate in practices or games in the 12 month period prior to the transfer. In addition to completion of the transfer form as part of the on-line registration process, a "Compliance and Authorization Form" must be submitted and signed by the Principals and Athletic Directors of both the leaving and receiving schools, and the student's parent or guardian, confirming that the student has not participated in the particular sport in school, club, community or representative competition during the 12 month period prior to the date of transfer. The completed form must be received by the BCSS office before the student can participate in any restricted competition.

4) the administrator of the boarding school assumes "in loco parentis" responsibility for the student.

ii) the student is transferring from any school outside of British Columbia to a BCSS Member School as a boarder, and

1) the boarding school submits a letter confirming that the student has not transferred for athletic reasons and,

2) the letter also confirms that the student is not receiving any financial assistance (scholarship or bursary) from the boarding school, and

3) the incoming student will be enrolled at the boarding school for at least 5 consecutive months, or one semester.

4) the administrator of the boarding school assumes "in loco parentis" responsibility for the student. ("Confirmation of Eligible Student Transfer Form" must be completed on-line with the registration of the student on the on-line Player Registration Form)

l) k) Incoming International Students to a Public School District A student who transfers into a BCSS Public School Member School as an incoming international student is eligible to compete for the receiving school if they meet all of the following conditions:

i) the students transfers into British Columbia from a country other than Canada or the United States.

ii) the student is registered in a public school district as an "international student", and pays tuition to that school district as per established and published school district policy

iii) the student has been accepted by that school district on the basis of academic suitability

iv) the incoming student will be enrolled at the receiving school for at least a consecutive five month or one semester period.

v) the superintendent of the school district or their district designate responsible for the international student program shall verify in writing that:

1) the acceptance of the student and placement of the student in a particular school is based solely on academic criteria, and

2) that a student's possible participation in extra-curricular athletics was not a factor in acceptance to the school district or a particular school, and

3) this verification will be submitted to the BCSS office prior to any participation in restricted competition in BCSS-approved sports.

vi) Guardianship has been established by school district personnel or the custodial home-stay or the student has been assigned to the home-stay family as the off-shore family designate.

vii) the student has been placed in a home-stay with a family who has been resident in the school district for a

period of at least six (6) months prior to the home-stay placement. ("Confirmation of Eligible Student Transfer Form" must be completed on-line with the registration of the student on the on-line Player Registration Form)

m) l) Incoming International Students to an Independent School: A student who transfers into a BCSS Independent School Member School as an incoming international student is eligible to compete for the receiving school if they meet all of the following conditions:

- i) the student transfers into British Columbia from a country other than Canada or the United States.
- ii) the student is registered in a Member Independent School as an "international student", and pays tuition to that school according to a published International student policy and fee schedule.
- iii) the student has been accepted on the basis of academic suitability
- iv) the incoming student will be enrolled at the receiving school for at least a consecutive five month or one semester period.
- v) the Head of School or Principal shall verify in writing that:
 - 1) the acceptance of the student is based solely on academic criteria, and
 - 2) that a student's possible participation in extra-curricular athletics was not a factor in acceptance to the school, and
 - 3) the student is not receiving a scholarship, bursary or financial award resulting from or relating to athlete participation, and
 - 4) this verification will be submitted to the BCSS office prior to any participation in restricted competition in BCSS-approved sports.
- vi) the school or the Board of the school has registered as the student's custodian (guardian) for the duration of the student's stay at the school, and provides a copy of the Letter of Custodianship
- vii) the student is placed in a school dormitory or with a family who has been resident in the community for a period of at least six (6) months prior to the homestay placement. ("Confirmation of Eligible Student Transfer Form" must be completed on-line with the registration of the student on the on-line Player Registration Form)

n) m) Ward of the Province: The student who transfers is a ward of the province and the move has been arranged by the province.

- i) the receiving school must submit a letter from the school administrator confirming that the placement has been arranged by the ministry having jurisdiction or the government agency responsible for the student. This letter will include the time of the move, the location of the new residence, and that participation in school sports was not a factor in the placement.
- ii) the receiving school must also confirm that the residence of the family or the residence in which the student has been placed is within the catchment area boundaries of the school.

o) n) School District Transfer: Student transfers in during the month of September as a result of the School District Transfer process.

- i) per section 74.1 of The School Act, a board must have a protocol in place to allow student movement among schools and therefore,
- ii) per School District Policy, the deadline for application for student transfer is in the spring, prior to the new school year, yet the board reserves the right to make a final decision after space and facility availability are known in the month of September.

Therefore, since the school district controls the date of transfer, a student should not be prejudiced in participating in athletics. The student may participate in athletics in their 3rd year of eligibility in their new school,

provided the board gives final approval for attendance prior to September 30th each year.

1. Each application must:
 - i) Be made for team activities only;
 - ii) Be made with regard to Member Schools that are located within close geographical proximity within the same zone;
 - iii) Be for a minimum period of three (3) years; and
 - iv) Be accompanied by a letter of request from the Member School(s) Principals, setting out the reasons for and in support of making the application.
2. Applications for joint teams from Member Schools shall be made:
 - i) By September 15th for teams to be involved in Fall activities;
 - ii) By November 1st for teams to be involved in Winter activities;
 - iii) By February 1st for teams to be involved in Spring activities;
3. In deciding whether or not to grant an application for a joint team the Compliance Officer shall consider, but is not limited to, the following:
 - i) The goal of allowing joint teams is to increase the number of students that participate in activities by making activities available for students that would not otherwise be available if joint teams were not accepted.
 - ii) It is preferable to combine smaller schools rather than having a small school combine with a larger school.
 - iii) Improving the quality of a team (i.e. better win/loss record) shall not be a criterion in deciding whether approval will be granted.
5. When an application is granted, the tiering classification of the joint team will be determined by the combined population of the two schools forming the joint team.
6. Applications, when granted, shall be for a 3 year term.
7. The Compliance Officer may terminate a joint team before the expiry of the 3 year period in the following cases:
 - i) Closure of one of the participating schools, or

- ii) Serious breach of the bylaws, policies or rules of the Association by any of the participants, or
- iii) When, in the opinion of the Compliance Officer, it is in the best interests of the students of one or more schools.

8. The Compliance Officer's decision is final and conclusive and shall not be appealed or reviewed in any manner.

6. Applications, when granted, shall be for a ~~3-year term~~ **1 year trial period**.

7. The Compliance Officer may terminate a joint team before the expiry of the ~~3-year period~~ **1 year trial period** in the following cases:

- i) Closure of one of the participating schools, or
- ii) Serious breach of the bylaws, policies or rules of the Association by any of the participants, or
- iii) When, in the opinion of the Compliance Officer, it is in the best interests of the students of one or more schools.
