

2026-2027 Change of Residence Form



A Change of Residence Form is required when a student-athlete changes their residence. This must be verified by the school administrator and signed by the student-athlete's parent(s) or legal guardian(s). Change of Residence Forms must be submitted within 12 months of the date of move.
